If you don't use email, you may call the Fair office at 541-343-4298. The office will do their best to answer your question. Otherwise, they'll send us a message to call you.

Please send the \$15 application fee (check or money order) and your printed application through the mail. Late applications and applications without the fee will not be considered. If you are concerned about delivery, send by certified mail. Because the crew picks up packages from the office periodically, the office staff cannot confirm status.

All crafts and services offered for sale at the Fair must be personally made or performed by the person whose name appears on the jury application.

The practitioner **plus** the art is what is approved by the Oregon Country Fair. The practitioner must be at the Fair, all three days, to sell the approved esoteric art.

Fill out your personal information and the information about your current craft status with the Fair. Please **do not** use a business name.

### Description, Results and Notification

Provide a description of your art. Our Craft Inventory database is built on Product, Technique and Material. So, a Reiki practitioner might be described as having a Product = healing, Technique = Reiki, Material = people and hands. We try to write the descriptive listings so that people wishing to find you at the Fair will be able to.

Please also provide a **thorough and convincing narrative** explaining your experience with and your commitment to this art. Brochures and testimonials and other helpful materials are welcome. **If you are applying with a culturally specific craft, we encourage you to include information regarding your relationship to that culture.** Because we have applicants from long distances, we can't do face-to-face interviews; we might need to make our choices based on the paperwork you send us. We will call or e-mail you with news and results as soon as we can (by May 1, 2025).

It's important to realize that because of limited space, most years we can accept only 2 or 3 esoteric artists.

Being successfully juried is not a guarantee of space to sell at the Fair — though we will do what we can to help. We encourage you to network with other booth people if you are accepted.
